## What can a third party do with an Authority to Deal?

With an Authority to Deal, a close member of your family that you trust can access your account to make transactions within the limits set out in the Authority terms and conditions.

Here are the things a third party can and cannot do:

## They can:

- Place instructions for the purchase or sale of securities
- Make decisions on Corporate Actions

## They cannot:

- Make changes to your personal details, like your address or phone number
- Make changes to your account, including setting up or changing any bank details
- Make changes to your account, including setting up, cancelling or changing any payments
- Move money from your account
- Make stock withdrawals
- Make stock transfers
- Close your account
